It may also be clearly specified whether the aforesaid employees are undergoing any penalty as a result of D&AR case.

The employees mentioned above may be directed for medical examination for Group 'B' Technical service as per Para 530 (a) of IRMM-2000 and the medical fitness certificate may be forwarded on or before **19.07.2023**. In terms of Para 533 of IRMM the authority competent to conduct medical examination of Non-Gazetted employees for promotion to Gazetted posts is Chief Medical Superintendent or Medical Superintendent in-Charge of the Division. Only those who qualify in the Medical Examination are eligible to attend viva-voce as per Railway Board's Lr.No.E(GP)80/2/8 dated 31.10.1991.
