The 70% Selection (Special Drive) for promotion from Group "C" to Group "B" service for the post of AME in Mechanical Department through CCBT for filling up of 6 (UR-5, SC-1, ST-Nil, Total-6, PwBD-1) was initiated vide Notifications dated 04.01.2024 & 18.01.2024.

A total number of 18 (UR-10, SC-6 & ST-2) eligible employees were alerted for the written examination. Among the 18 employees, 14 (UR-7, SC-5 & ST-2) employees attended the CCBT examination held on 17.03.2024.

8 (UR-5, SC-2 & ST-1) employees have secured qualifying marks in the CCBT examinations held on 17.03.2024 and all the 8 employees were sent for medical examination.

Among the 8 qualified employees who were sent for medical examination, Shri S. Jayaprakash, SSE(Mechanical)/CW/PER (Roll No. TN0101212066) has been declared **"Temporarily Unfit"** vide Medical Certificate No.564162 dated 15.04.2024. The decision regarding calling him for viva-voce will be taken on receipt of the appropriate medical certificate declaring him FIT for the promotion to the post of AME.

Having found fit in medical examination under Para 530(a) of IRMM 2000 edition, 7 (UR-4, SC-2 & ST-1) employees were alerted for Viva-Voce held on 23.04.2024. All the 7 employees have attended the Viva-Voce.

The above "Provisional Part Panel" is in the order of seniority and the inter-se position among the provisionally empanelled employees is likely to change when the panel is finalized.

Smt. S. Ramani, is provisionally to be charged against the post earmarked for SC and a final decision will be taken regarding charging her to a SC or UR point after receipt of the medical fitness/unfitness of Shri S. Jayaprakash.


Shri S. Jayaprakash,(UR) has been declared "Temporarily Unfit". Therefore, one UR vacancy has been kept unfilled and decision regarding filling up of this 01 UR vacancy will be taken on receipt of Medical Certificate of Shri S. Jayaprakash. Therefore, a subsequent DPC will be held on receipt of the Medical Certificate of Shri S. Jayaprakash.

In terms of Para 2 of Railway Board's letter No. E(GP)2021/2/2/EP dated 04.03.2021 (RBE No. 15/2021), 1(UR) employee, Shri Vinayan K.K, Sr. Section Engineer (Diesel) TVC being empaneled to the post of AME is retiring on 31.05.2024, which is within the vacancy cycle itself i.e., 01.01.2023-31.12.2024. Since the third candidate, Shri S. Jayaprakash, is yet to be called for Viva-Voce, the decision for extended panel will be taken after the receipt of the medical fitness/unfitness of Shri S. Jayaprakash.

Since no eligible PwBD employees have qualified in the written examination held on 17.03.2024, 01 (one) PwBD vacancy will be taken into account in the succeeding vacancy cycle by way of carrying forward of the reservation.

In terms of Railway Board's letter No.2018-E(SCT)I/25/9 dated 19.06.2018 (RBE No.91/2018) & (PBC No.116/2018), the above Panel is provisional and the promotion will be subject to further orders which may be passed by the Hon'ble Supreme Court.

The Provisional Part Panel has been approved by the General Manager on 29.04.2024.
