against the reserved vacancy of '1' (ST) as per Railway Board's letter No. 88-
E(SCT)/I/23/I dated 03.05.1989.

edition, both the ST employees have attended the Viva-voce held on 07.05.2024
under "best amongst the failed candidates" scheme.
