The selection for promotion from Group 'C' to Group 'B' service against 70%
(Regular) in the Civil Engineering Department for filling 13 vacancies (UR - 9, SC -
01, ST - 03 Total - 13, PwBD-1) was conducted vide this office notification dated
10.01.2024.

A total number of 41 eligible employees (UR - 28, SC - 8 & ST - 05) were
alerted for the CCBT. The CCBT main exam was held on 17.03.2024. Among the 41
employees, only 39 employees (UR - 26, SC - 8 & ST - 5) appeared for the main
examination.

Out of 39 employees, only 21 employees (UR - 17, SC - 3 & ST - 1) secured requisite qualifying marks i.e minimum 60 marks out of 100. All 21 employees were sent for medical examination. Out of 21 employees, Shri S.Suresh Kumar, SSE (DRAWING-CIVIL)/HQ was found medically unfit hence not eligible to attend the Viva-voce.

While issuing the letter dated 24.04.2024 calling for viva-voce, the Medical Certificate of Shri. R.Sundaresan, SSE/Drawing-Civil/CN/MS, had not been received. Therefore, it was indicated in the letter calling for viva-voce that the decision regarding calling him for viva-voce will be taken on receipt of the appropriate medical certificate declaring him FIT for the promotion to the post of AEN. Hence, 19 employees were called vide letter dated 24.04.2024 to attend the Viva-voce. All the 19 employees attended the viva-voce held on 25.04.2024.

The under mentioned Group 'C' employees of Engineering Department have obtained qualifying marks in the written examination held on 17.03.2024, Record of Service and Viva-Voce held on 25.04.2024 for promotion to Group 'B' service, for the post of AEN against 70% Selection (Special Drive) and placed in the Provisional Panel as under:



Since Shri R.Sundaresan, SSE/Drawing-Civil has been certified as "UNFIT for the Group "B" post of AEN even in the PwBD category", he is not eligible to be called for the viva-voce.

Since no eligible PwBD employees have qualified in the written examination held on 17.03.2024, 01 (One) PwBD vacancy will be taken into account in the succeeding vacancy cycle by way of carrying forward of the reservation.

In terms of Railway Board's letter No. 2018-E(SCT)I/25/9 dated 19.06.2018 (RBE No. 91/2018 & PBC No.116/2018), the above Panel is provisional and the promotions will be subject to further orders which may be passed by the Hon'ble Supreme Court.
