The Selection for promotion from Group 'C' to Group 'B' service for the post of
AEE 70% Selection (Special drive) through CCBT in Electrical Department for filling
up of 8 (UR-6, SC-1, ST-1, Total-8, PwBD-1) vacancies was initiated vide notification
dated 12.01.2024.

A total number of 18 (UR-11, SC-7 & ST-NIL) eligible employees were alerted
for the CCBT. Among the 18 employees, only 13 (UR-7, SC-6 & ST-NIL) employees
attended the CCBT held on 17.03.2024.

Out of 13 employees, only 8 (UR-5, SC-3 & ST-NIL) employees secured
qualifying marks i.e., minimum 60 marks out of 100 in the CCBT held on 17.03.2024.

After being found fit in medical examination under Para 530(a) of IRMM 2000 edition, all the 8 (UR-5, SC-3 & ST-NIL) qualified employees were alerted for Viva-voce test held on 24.04.2024.

The under mentioned Group 'C' employees of Electrical Department have obtained qualifying marks in the written examination held on 17.03.2024, Record of Service and Viva-Voce held on 24.04.2024 for promotion to Group 'B' service for the post of Assistant Electrical Engineer (AEE) against 70% Selection (Special Drive) and are placed in the provisional panel as under:

None of the ST employees had expressed willingness for the above Selection, hence one ST vacancy remains unfilled.

Since no eligible PwBD employees have qualified in the written examination held on 17.03.2024, 01 PwBD vacancy will be taken into account in the succeeding vacancy cycle by way of carrying forward of the reservation, subject to extant instructions.

As none of the employees being empaneled are retiring within the vacancy cycle of the 70% Selection (Special Drive) (i.e., on or before 31.12.2024) there is no need for an extended panel.

In terms of Railway Board's letter No. 2018-E(SCT)/I/25/9 dated 19.06.2018 (RBE No. 91/2018) & (PBC No. 116/2018), the above Panel is provisional and the promotions will be subject to further orders which may be passed by the Hon'ble Supreme Court.

The Provisional Panel has been approved by the General Manager on 29.04.2024.
