There is no Pre Promotional Training (PPT) as the vacancy is earmarked for 'UR' only.

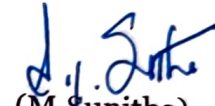
In terms of Railway Board's letter No.79-E(SCT)15/1981 and No.87-E(SCT)1/31/5 dated 02/12/1987, community certificate of Reserved Community employees should be verified, particularly at the stage when the candidates are to be considered for promotion to the next higher grade.
