Shri T.Prabhu, (SC), CLA/Law Branch/HQ, who is willing to attend Pre promotional Training (PPT) may be directed to attend the PPT Training at Law Branch/HQ from 06.12.2024 to 23.12.2024 without fail. The controlling officer should ensure that the employee is relieved in time to attend the Pre-Promotional Training.

In case, if the employee who has expressed willingness but fail to attend the Pre-Promotional Training on the specified dates in spite of notification, he will have to appear for the written examination without such PPT being imparted.

In terms of Railway Board's letter No.79-E(SCT)15/98 dated 18/12/1981 and No.87-E(SCT)1/31/5 dated 02/12/1987, community certificate of Reserved Community employees should be verified, particularly at the stage when the candidates are to be considered for promotion to the next higher grade.
