32 (UR-24, SC-5 & ST-3) employees who have secured the requisite qualifying marks in the written examination (CCBT) were directed for medical examination vide this office letter dated 17.07.2026 cited under reference.

Having found fit in the medical examination under Para 530 (a) of IRMM 2000 edition, 30 (UR-23, SC-4 & ST-3) employees were alerted for Viva-Voce held on 05.08.2026 vide this office letter dated 31.07.2026 cited. All the 30 employees have attended the Viva-Voce.
