- 5) APARS completed in all respects for the last 5 years (PE-31.03.2021, 31.03.2022, 31.03.2023, 31.03.2024 and 31.03.2025) with acknowledgement for having served the APARs to the employees and certification that there is no further appeal pending.

It may also be clearly specified whether the aforesaid employees are undergoing any penalty or charge sheet issued as a result of D&AR case. If any of the employees are undergoing penalty of reduction to lower grade etc. or under suspension or any departmental proceedings have been initiated for major or minor penalty or any RPUP cases are pending, the particulars of such employees should also be advised with details to Dy.CPO/Gaz/HQ in a sealed cover.

It is the personal responsibility of the Cadre Controlling Personnel Officers to ensure that SRs and APARs are updated and current in all respects and forwarded to this office **on or before 24.07.2026.**
