533 of IRMM-2000 edition, the competent authority to conduct Medical Examination for Non-Gazetted employees for promotion to Gazetted post is CMS/MS in-charge of the Divisions/Units. The Medical certificates of aforementioned employees may be forwarded to this Office at the earliest. Only those who qualify in the Medical Examination are eligible to attend viva-voce as per Railway Board's Lr. No.E(GP)80/2/8 dtd. 31.10.1991.

The aforementioned employees qualified in CCBT will be called for viva-voce subject to the Medical fitness in Group – B Technical Service as per Para 530 (a) of IRMM, 2000 edition.

The respective Personnel Officers should forward the following documents to the undersigned through OS/Ch.OS/S&WI/Ch.S&WI **on or before 24.07.2026.**

- 1) Medical Fitness Certificate duly signed by respective CMS/MS incharge of Divisions/Units.
- 2) D&AR Status along with relevant documents such as NIP, Charge Memorandum, etc. as the case may be.
- 3) Vigilance/SPE status.
- 4) SRs updated in all respects.
- 5) APARs completed in all respects for the last 05 (five) years (PE.31.03.2021, 31.03.2022, 31.03.2023, 31.03.2024, 31.03.2025) with acknowledgement for having served the APARs to the employees and certification that there is no further appeal pending.

It may also be clearly specified whether the aforesaid employees are undergoing any penalty or charge sheet issued as a result of D&AR case. If any, of the employees are undergoing penalty of reduction to lower grade etc or under suspension or any departmental proceedings have been initiated for major or minor penalty or any RPUP cases are pending, the particulars of such employees should also be provided with details to Dy.CPO/Gaz/HQ in a sealed cover.

It is the personal responsibility of the Cadre Controlling Personnel Officers to ensure that SRs and APARs are updated and current in all respects and forwarded to this Office **on or before 24.07.2026.**
