Sub- Notification for filling up of vacancies of Instructor/Safety Camp [Ex-Cadre] in Level 7 of VII PC on Tenure basis.

It is proposed to conduct a selection for filling up of 1 vacancies of 1(ONE) Instructor/Safety Camp in PML-7 of 7th CPC [Ex-Cadre] at MDZTI/TPJ by calling volunteers from eligible employees in PML-6 & 7.

1.0 Eligibility Criteria:

Employees/Volunteers called from	Staff working in Transportation Department holding the post of SS/SMs in PML-6 & 7 on regular measure in Divisions (not in MACP) may be considered.
Age Limit	Upper Age limit as on the date of notification is 52 years.
Conditions for applications	Employees already working in another Ex-Cadre post need not apply. It should be ensured that while forwarding the application of volunteers, necessary conditions as indicated in PBC169/2001 & 72/2005 are strictly complied. Staff who have once completed their tenure as Instructor should have worked at least for a minimum period of one year in their parent cadre.
Tenure	Tenure period is 5 years. They will be repatriated to parent cadre on completion of their tenure period or 3 months prior to the date of their retirement or when their performance is found to be not satisfactory at any time without assigning any reasons whatsoever, whichever is earlier.
Educational Qualifications	Qualified in GRS and should possess BCC. Computer literacy and knowledge in Hindi is desirable.

2) SELECTION PROCEDURE:

- 100% objective type Written examination with negative marking followed by Class Room Trial in respect of qualified candidates in the written examination.
- ii) In terms of PBC No.263/2018 and 46/2019 the Written examination shall Comprise of 100 Objective type multiple choice questions.
- in terms of PBC No.264/2019, there shall be negative marking @ 1/3rd mark reduced for every wrong answer.
- Selection will be based on merit as per the instructions contained in RBE No.4/2020 read with RBE No.39/2020.
- In the event of selection of an employee in PML-6, the exchange of posts between Division/Institute for the tenure period will be done and there will not be any pay fixation on this account.
